



## Privacy Notice for Richard Clegg

Thank you for choosing to instruct me in your case. I will need to collect and hold your personal information in order to represent you. I will take all possible steps to protect your personal information. I am determined to do nothing that would infringe your rights or undermine your trust. This Privacy Notice describes the information I collect about you, how it is used and shared, and your rights regarding it.

### Data Controller

I am registered with the Information Commissioner's Office (ICO) as a Data Controller for the personal data that I hold and process as a barrister. My registered address is Selborne Chambers, 10 Essex Street, London WC2R 3AA and my registration number is Z6586732.

### Data Collection

All or the vast majority of the information that I hold about you is provided to or gathered in the course of your case and/or proceedings. Your solicitor and/or I will tell you why we need the information and how we will use it.

### The Lawful Basis for processing your information

The General Data Protection Regulation (GDPR) requires all organisations that process personal data to have a Lawful Basis for doing so. The Lawful Bases identified in the GDPR and which apply as between us are:

- The data subject has consented to the processing.
- The processing is necessary:
  - In relation to a contract which the data subject has entered into; or
  - Because the data subject has asked for something to be done so they can enter into a contract; or
  - Because of a legal obligation that applies to me;
- Performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.
- The legitimate interests of ourselves, or a third party, except where such interests are overridden by the interests, rights or freedoms of the data subject.

- Assist in training pupils and mini-pupils

- Investigate and address your concerns;
- Communicate with you about news, updates and events;
- Investigate or address legal proceedings relating to your use of my services/products, or as otherwise allowed by applicable law;

I do not use automated decision-making in the processing of your personal data.

#### **Client data**

- Location details;
- Device IP address;
- Financial information
- Medical records
- Criminal records

#### **I may share your personal data with:**

- Instructing solicitors
- A Pupil or mini pupil, under my training
- Opposing Counsel, for the purposes of resolving the case
- My Chambers management and staff who provide administrative services
- My regulator or legal advisors in the event of a dispute or other legal matter;
- Law enforcement officials, government authorities, or other third parties to meet our legal obligations;
- Any other party where I ask you and you consent to the sharing.

#### **Transfers to third countries and international organisations**

On occasions I transfer personal data to third countries or international organisations including by my use of Dropbox which has servers in the USA and operates the 'Privacy Shield' Scheme.

I am satisfied that all such transferred data is fully protected and safeguarded as required by the General Data Protection Regulation.

I retain your personal data while you remain a client and subject to my Retention and Disposal Policy (copy available on request). ## Your Rights

Finally, if I do something irregular or improper with your personal data you can seek compensation for any distress you are caused or loss you have incurred.
